- "The School will follow the syllabus on the basis of curriculum prescribed by NCERT for the middle classes."
- The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT.
- 3. The school will follow CCE scheme vide Circular No. 39/20-09-2009 dated 20.09.2009 in the school.
- 4. The grant for approval of the middle classes is not extendable and does not in any way imply any obligation on the part of the Board to affiliate the Secondary Classes (IX-X).
- The approval will also be subject to the condition that the school will make a fresh application for Provisional Affiliation of the Secondary Classes (IX-X) to the Board on line through CBSE website www.cbseaff.nic.in or www.cbse.nic.in in accordance with the rules and condition for Provisional Affiliation when classes VIII has been started.
- The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under :-

10. The school and its records shall be opened for inspection by an officer/official of the Board or an authorised representative of the Board/State Educational Department at any time and the school shall furnish information as may be asked for by the Board/State Government from time to time.

11. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.

12. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.

13. No unrecognized classes shall run within the premises of the school or outside in the same name of school.

14. The school will abide itself by the rules and conditions for affiliation as given in the Affiliation Bye Laws of the Board.

15. The school shall promote inclusion of student with disabilities/special needs in the normal school as per provisions of

the 'persons with disabilities act-1995'.

16. The school should have at least one adequately equipped computer lab with a minimum of 10 computers or computer student ratio of 1200 and 1200 student ratio of 1:20 and proper software alongwith facility of Broad Band Connectivity with the feature of 'internet always on' from any service provider.

17. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared in the name of school as per rules. A copy each of the Statements of Accounts should be

sent to the Board every year.

18. The affiliation Code Number allotted to your school is 1930452. This may please be noted and quoted for any correspondence with the Board.

19. Reserve Fund be maintained in the joint name of the Secretary, CBSE and the School Authorities in accordance with the enrolment in the school from time to time.
